Pro Grigioni Italiano (PGI) is the organisation for the preservation and promotion of the Italian language and culture in Graubünden and in the Swiss Confederation. After PGI was established in 1918 as a central organisation in Chur, it was reorganised in 1943 into sections in the Italian part of Graubünden and the large towns of Switzerland. With the complete revision of the statutes in 2007 PGI now has founded four centres of competence (Misox and Calanca, Puschlav, Bergell, Chur), which together with the main office and the sections work for the protection of Italian in all fields of private and public life.

PGI is recognised by the canton of Graubünden, by the Swiss state and by the Council of Europe as legitimate representative of the autochthonous minority of the Italian-speaking population of Graubünden (Italian Switzerland) and protects their interests on all governmental levels in Switzerland as well as internationally.
